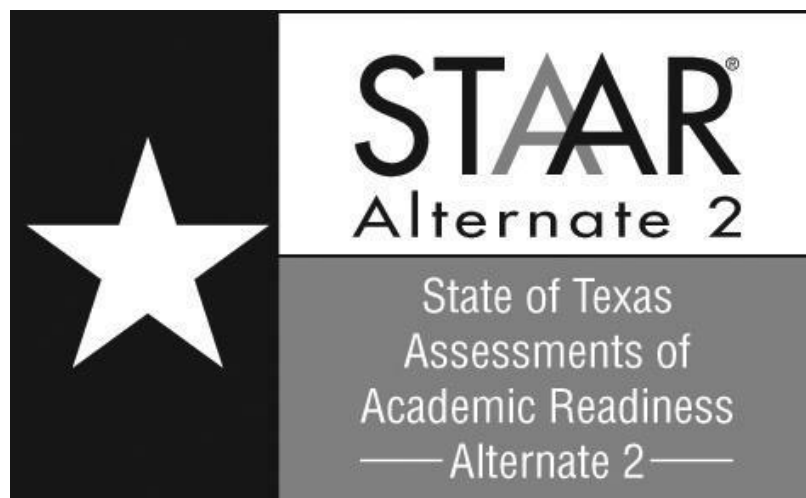


STAAR Alternate 2 End-of-Course 2021 Test Administration



Reporting Student Data File Format

Overview

Following is a list of the most significant changes being implemented in the 2021 STAAR Alternate 2 Reporting Student Data File Format.

- Added value of E under LEP-Indicator-Code. See Position 107.
- Removed Career-and-Technical-Ed-Indicator field. See Position 122.

The following changes are due to the cancelation of the 2020 STAAR Alternate 2 administration.

- Progress Measure will be based on 2019 data. See Position 400.
- On-Track Measure will be blank. See Position 401.
- Previous Year History will reflect 2019 data. See Positions 402-416.

NOTE: The data will be provided in a fixed-length text file format with the layout defined below. The file extension will be .txt. Tab-delimited files are not available.
